Reza Lahidji is an economist specialised in policy analysis and evaluation and the head of the Evaluation and Governance Practice at KPMG IDAS. Reza has a detailed understanding of Agenda 2030 and has carried out research on the measurement of progress towards SDG 16 (peace, justice and strong institutions).

An economist by background, Reza is a recognized expert in policy analysis and evaluation methods. He devoted his PhD thesis to the study of policy evaluation and assessment tools and has extensively worked on theory-based evaluations. He has also led several futures studies and is familiar with systems analysis, having published a flagship OECD report on a systems approach to the management of emerging risks, including natural disasters and infectious diseases. Reza has often collaborated with scientists, engineers and lawyers inside multi-disciplinary teams and is regularly consulted by technical regulatory bodies.
